- 1.5% APY (Annual Percentage Yield) on average daily balances over \$2,000
- 1.0% APY on average daily balances below \$2,000

Institutional Money Market Account

Account Features

- \$5,000 minimum opening balance requirement
- 1.85% APY on balances between \$5,000 and \$19,999.99
- 3.50% APY on balances above \$20,000
- 0.00% below \$5,000
- Maximum of 6 withdrawals per month

All checking and money market rates are effective 3/1/26 and subject to change.

Account Features

- \$10,000 credit limit
- Minimum interest rate 11.0% APR (Annual Percentage Rate) to a maximum interest rate of 18.0% APR
- Up to 10 card holders
